HU9004	The objective of the first programme is to strengthen or establish the institutions of the sector that either did not have the capacity for operation in market economy conditions or they were completely absent in the previous structure.	€20 million
HU9104	The second programme focused the support on two areas. The first area was to help the starting Hungarian agro-economic privatisation in the grains, dairy and meat industry sectors, as well as in forestry and wood industry. The other part of the support was received in expert consultancy provided for restructuring state farms and co-operative farms.	€13 million
HU9202	The third programme facilitated the establishment of a financial/banking infrastructure capable of performing the financing tasks of rural economy.	€5 million
HU9304	The fourth programme was intended to help the entrepreneurs in the sector and facilitate to implement their investments.	€30.5 million
HU9505	The fifth programme concentrated on preparing the main institutions of the agricultural sector for integration.	€10 million
HU9806	Within the programme a total of €16 million was used in areas to develop the institutional system of animal and plant health, to establish the institutional system of the Common Agricultural Policy, to enhance quality assurance and increase the competitiveness of the food industry, as well as to develop the institutions of rural development and agri-environmental protection.	€16 million
HU9909	In the programme EU funds of €14.9 million was used to develop the plant protection service and frontier crossing points, to develop the registration of title deeds and to develop the system of agri-statistics.	€14.9 million
HU0003	In the programme EU funds of €8 million was allocated for developing the institutional system of animal health (pig registration database, building frontier crossing points, elaborating animal welfare measures).	€8 million
HU0102	In the amount of EU funds totalling €5.5 million, the projects of the programme involved areas of improving the institutional system of animal and plant health, developing the forestry service (registration of plant protective and fertility enhancing agents being in conformity with EU, building the system animal and plant health connected with railway frontier crossing points, establishing a statistical system at the Forestry Service in conformity with EU, facilitating the accreditation of the SAPARD Office)	€5.5 million
HU02	The programme closing down this year involves six projects with EU funds of €11.05 million: introducing the rules of procedure of common market organizations; monitoring the Bovine Spongiform Encephalopathy; introducing the measures of the European Agricultural Guidance and Guarantee Fund (EAGGF), cooperating in the establishment of a separate long term expert team - ARDOP MA, as well as developing ARDOP, with an assessment of the institutional system of SAPARD; developing the classification of sowing seed, plant propagation materials and forage; establishing the registration system for sheep and goats; organising the Food Safety Office.	€11.05 million
HU03	The projects were aimed at establishing the integrated administrative system, protecting against rabies; developing the laboratory of the plant and soil protection service.	€17.33 million.
